


Whereas the Settlor is desirous of establishing a Trust for private charitable objects.

And whereas the Trustees have, at the request of the Settlor, agreed to act as the first Trustees of these presents as testified by their being parties to executing these presents.

And whereas it is necessary to declare the objects and terms of the Public Charitable Trust, being constituted under these presents.

Now this declaration witnesseth as follows:

(i). That, in order to effectuate his aforesaid desire, the Settlor has set apart and handed over to the Trustees, a sum of Rs. 51,000/- (hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the Trustees or may come to their hands by virtue of gifts or donations), and the Trustees shall hold and stand possessed of the same upon the Trust subject to the powers, provisions, agreements and declarations hereinafter contained.

That the name of the Trust shall be Bisheshwar Malti Welfare Trust and its office shall, for the present, be situated at Chaudhary Tola, Mahendru, PATNA, BIHAR, and/or at such other place or places as the Trustees may decide from time to time.

That the objects for which this Trust is established are:


- (1) To establish, manage and maintain schools, colleges, libraries, and adult education centers conduct course and vocational Institutions by the society.


- (2) To establish, maintain and manage hostel to procure other accommodation, which are necessary for the residence of the students.
  - (3) To start the conduct magazines, periodicals to carry on educational propaganda and further the aims and objects of the society by means of lectures and various other means.
  - (4) To provide, establish maintain, control and manage society and to do all acts and things necessary for or conducive to the promotion of EDUCATION at Patna and for this purpose to start, establish conduct, maintain and manage reading room and Libraries, Hostels and the like.
  - (5) To spread professional education.
  - (6) To gives loans, scholarship, free ships, prizes and monetary assistance to student or the society's to help them in their studies.
  - (7) To acquire land gift, purchase, exchange, lease on hire or otherwise howsoever any land, buildings, easements, right or common play grounds parks a by property movable and or immovable and for any estate interest for the furtherance of all or any of the object of the society.
  - (8) To build, construct and maintain house or other buildings and alter extend, improve, repair, enlarge or modify the same including any existing buildings and to provide and equip the with light, water, drainage, furniture & fittings, instrument, apparatus and appliances
  - (9) To pay out of the funds belonging to the society or out of any particular part of such fund all expenses of or incidental to the formation of the Trust and management and administration of any of foregoing object including all rent, rates, taxes, out going and salaries of the employees.
  - (10) To do all such other lawful acts, deeds or things as are incidental or conducive to the attainment of any of the above objects.
- (ii) The Trustees shall use the properties and funds of the Trust and incomes and profits there from to pay expenses and

meet obligations arising from activities undertaken for the aims, objects and purposes hereinbefore declared and incidental to the administration of the Trust. It is hereby expressly declared that no part of the Trust property or income of the Trust shall be used for any purpose which is not a public charitable purpose.

(iii) That the Trust Fund shall not be used for any purpose other than those specified in Clause 3 hereinabove.

(iv) That the Trustees shall maintain proper accounts of the Trust which shall be kept at the office of the Trust.

(v) That for the furtherance of the objects of the Trust, the Trustees shall have all necessary powers required to manage the Trust and its property.

(vi) The number of Trustees shall not be less than two and more than seven. If the number of Trustees shall fall below two, the remaining Trustee shall not, except for the purposes of filling any vacancy, act so long as the number is below the said minimum.

(vii) A person or persons can be appointed Trustee or Trustees by the existing Trustees provided all of them, without any dissent or abstention, agree on the name or names.


(viii) All Trustees shall be Trustees for life. A person shall cease to be Trustee only upon resignation, mental incapacitation or death. In particular, no Trustee can be removed from office by other Trustees.

(i) Subject to Clauses 10 and 11, all matters shall be decided by a two thirds majority of all Trustees.

(ii) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of more than two thirds of the Trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.

(ix) The accounting year of the Trust shall be the financial year ending on 31st March every year.

(x) There will be a bank account of the Trust. The bank account shall be operated by the office bearers designated by the Trustees for the purpose.

(xi) (a) The Trust can be dissolved if in a meeting specially convened to decide on the dissolution more than two thirds of all Trustees vote in favour of dissolution.

(b) On dissolution of the Trust all properties, assets, and funds belonging to the Trust net of all debts and liabilities are to be transferred to another trust or trusts having same or similar objectives as this Trust.


In cases of necessity and for the benefit of the Trust estate, Trustees shall be at liberty, at his or their discretion, to sell, mortgage, transfer, alienate, partition, and /or demise the Trust properties mentioned in the said Schedule hereto or any part thereof subject to the prior sanction of the Board of Trustees for the benefit of Trustees. And to invest the moneys there raised and in the event proceeds thereof as well as such investments shall form part of the Trust estate but no purchaser, mortgagee, transferee, aliened, co-sharer


